The month of May started off with an exciting virtual gathering of nearly 40 people representing kinship families and service providers for the second meeting of the Michigan Kinship Care Coalition (MKCC). The Coalition discussed how to best support families in the current environment and adopted the following values' statement:

The Coalition's work is driven by:

- Inclusion of the voices and leadership of kinship families;
- Collaboration with a diverse group of stakeholders from across the state;
- Maximizing partnerships to achieve high-quality, coordinated systems of support; and,
- Commitment to advocating for improved outcomes.

The next Michigan Kinship Care Coalition quarterly meeting is Monday, August 10th from 1-3pm. There are currently five committees within the Coalition: Policy and Advocacy, Public Awareness and Education, Information Sharing, Caregiver and Service Provider Trainings and Mobilizing the Field. Older American Act Reauthorized
The Older Americans Act was originally passed by Congress in 1965 to address the lack of services for older and aging adults. The most recent version of the law was passed in in March as the Support Older Americans Act of 2020. The act reauthorizes activities and programs under the Older Americans Act through 2024. It also removes the cap on using National Family Caregiver Support Program by expanding the amount of funds available to serve grandfamilies. It also includes language to make improvements to a
